Elections Update

2018 ANCHORAGE MUNICIPAL ELECTION UPDATE

The April 3rd Municipal election will be conducted By Mail, supplemented by four Accessible Vote Centers open from March 26th through 8 p.m. on April 3rd; Anchorage City Hall, Loussac Library, MOA Election Center (619 East Ship Creek Ave), and Eagle River Town Center. There will be no polling places on Election Day other than the Accessible Vote Centers.

Ballots will be mailed 21 days prior to election day—March 13th—to the address on file with the State Division of Elections (or a PO Box if so indicated on your official registration form). Ballot material is not forwardable. Visit <u>elections.alaska.gov</u> and Register to Vote, Cancel My Alaska Voter Registration, Check my Voter Registration Status, Update my Voter Registration Information. If you want to receive your ballot package at a temporary address, complete an Absentee Ballot Application by visiting: www.muni.org/2018Application.

Vote your ballot, sign the voter declaration and return your ballot in one of 3 ways:

- 1) Place 1st class postage stamp on the Envelope. Drop in a US P.O. box or deliver to a Post Office. Envelope must be postmarked on or before April 3.
- 2) Place Envelope in one of 12 secure Drop Boxes on or by 8 p.m., April 3. They are open 24/7 three weeks before Election Day. Visit <u>muni.org/elections</u> for locations.
- 3) Drop off the Envelope at an Accessible Vote Center by 8 p.m. on April 3.


Vote By Mail Presentations

VOTER SERVICE REPORT

Non-Naturalization Voter Registrations

<u>High School Students</u>: A total of 141 high school students were registered to vote between December 1 & December 15. Three LWV registrars registered students at four high schools: East (47 students), Chugiak (38 students), South (28 students) and Bartlett (28 students). This was the first time we registered students at South and Bartlett.

High School Government teachers at East, Service, Bartlett, and Chugiak have been contacted to see if LWV registrars can visit classrooms between now and March 3 to register eligible students so they may participate in the Spring municipal election. In addition to reminding seniors planning to attend out-of-state colleges to **NOT** register to vote at their college campuses, registrars will be informing students what to do if they do not receive their mailed ballots prior to the April 3rd election. Thus far, we are committed to register students to vote at South High on February 15 and working on a date for Service High Government classes.

UAA Campus Vote

A total of 71 individuals were newly registered to vote or updated their voter registration at events held last Spring (11) and Fall (60).

Food Bank Event

Seven LWV Registrars registered a total of 47 individuals over a two-day Food Bank event at Sullivan Arena in mid-December.

Naturalization Ceremonies

We have been invited to participate, along with the Anchorage Women's Club, in registering new citizens to vote at Judicial Naturalization ceremonies held at the Fitzgerald Courthouse on 7th Ave. I met with a representative of the court for a short orientation. We have a list of ceremony dates (one per month, thus far) and will be recruiting registrars to cover those ceremonies. The first judicial ceremony was held on Friday, January 26.


IMPORTANT DATES


LWVAK—Domestic Violence and Sexual Assault Position Statement

At last spring's LWVAK's Convention, attendees decided the LWVAK's position on Domestic Violence and Sexual Assault should be updated to include bullying. Attached at the end of this newsletter is a draft of an update ready for League member feedback. Feedback is due by Thursday, February 15 and should be sent to winstonsmommem@gmail.com for consideration. The Anchorage board will consolidate the comments and forward to the LWVAK board. The draft will be presented in its final draft form to the LWVAK board for approval at their March meeting. The updated position will then be placed on the LWVAK website.

The Anchorage board discussed the position statement at the January 17 board meeting and offered the following feedback:

- 1. Change the title to "Domestic Violence, Sexual Assault and Bullying.
- 2. Under "Prevention" Item 3; delete in the last sentence "both middle and high schools" and replace with "all levels of education".
- 3. Under "Public Services to Victims" add after Item 4 a new Item 5 and renumber the rest; "When appropriate a sufficient number of certified sexual assault nurse examiners must be available."
- 4. Under "Definitions"; Bullying—remove "or between partners" as the "Domestic Violence" definition addresses family members which includes partners.
- 5. Under "Definitions" Domestic Violence—remove "and bullying" as "Domestic Violence" has a very specific definition and "Bullying" has a very specific definition.
- 6. Under "Definitions" Domestic Violence—remove "peers" and add "partners" which is in line with the meaning of "household or family members".

Due to the endless legal battles from states refusing to release voter information, the Integrity Commission was dissolved on January 3, 2018. The commission was created in May 2017 and held two meetings. The commission was requesting detailed voter data, including the names, addresses, birthdates, partial Social Security numbers, party affiliation, felon status and other data for every registered voter. The Department of Homeland Security has been tasked to look at the issue.

Become a Member of the Municipal Election Commission

The Election Commission is a body appointed by the Mayor and confirmed by the Assembly. Members typically serve a three-year term; members can be reappointed for additional terms. The commission is comprised of five members—currently there are two vacancies.

The qualifications of Election Commission members are included in AMC 4.50.035 and include, in addition to AMC 28.10.030, that a member shall (1) if legally eligible, be a qualified voter of the municipality; (2) maintain domicile in the municipality while in office; (3) be at least 18 years of age or meet state requirements relating to employment of minors during the member's service to the board or commission.

The Election Commission acts in an advisory capacity to the Anchorage Assembly and the Municipal Clerk in the conduct of elections; studies and recommends to the Assembly and Municipal Clerk proposed ordinances relating to elections; serves as the canvass board for Municipal Elections; and reviews the results of the election officials' tabulation; among other assigned duties. AMC 28.120.060.

The Anchorage Election Commission is required to hold an organizational meeting each year. AMC 28.120.030. The Commission typically elects a Chair and a Vice-Chair, reviews its procedures and the election calendar, and establishes a meeting and training schedule.

Election Worker Position

Temporary positions are available with the Municipal Clerk's Office through June 2018.

Location: MOA Election Center, 619 East Ship Creek Drive.

Hours: Monday through Friday; 8:00 a.m. to 5:00 p.m. and may be variable.

Salary: \$12.00/hour.

Application Period: Closes 5:00 p.m. AST; Tuesday, February 6, 2018.

<u>Example of Duties</u>: Provide election support for the Municipal Clerk's Office prior to and immediately after regular or special municipal elections. Assist with review of initiative or referendum petitions signatures. Prepare election supplies and equipment, conduct data entry, review voter qualifications, and mail absentee ballots. Utilize Microsoft Access database to determine the appropriate ballot for voters to use.

Prepare form letters in Microsoft Word, including using mail merge, prepare checklists and spreadsheets in Microsoft Excel, operate the mail sorter machine, conduct signature verification, and operate scanners and other office machines.

Some Election Worker assignments may require lifting and carrying of mail trays and other items that weigh 20 to 50 pounds. Some assignments may require the ability to bend, stoop and kneel.

A driver's license and current vehicle insurance will be required if the selected position requires driving between various work locations.

Assist the public in person, using multi-line telephone systems and via email. Required to take an oath of office and are prohibited from engaging in partisan politics in any manner, as detailed in Anchorage Municipal Code 2.20.055D. Perform other election related duties as assigned or required.
