**Letter to the Citizens' Stamp Advisory Committee promoting the issuance of a commemorative stamp in honor of the ratification of the 19 Amendment**

On April 24, 2018 the Anchorage League sent a letter endorsing the commemorative stamp: We understand that the Citizens' Stamp Advisory Committee is considering the issuance of a commemorative stamp in honor of the ratification of the 19<sup>th</sup> amendment which gave women the right to vote. Since over half of the citizenry of the United States are women, we trust this stamp would receive widespread support.

As a representative of League of Women Voters of Anchorage, Alaska, I am asking the Citizens' Stamp Advisory Committee to recommend to Megan J. Brennan, our Postmaster General, that this stamp be approved for general circulation. Since the 19<sup>th</sup> Amendment was ratified on August 18, 1920 and was officially proclaimed the law of the land on August 26 of that same year, we encourage the release date of the stamp to occur in 2020, coinciding with the 100<sup>th</sup> anniversary of this significant, historic event.

As you know, the League of Women Voters (LWV) was created by the suffragists who were members of the National American Woman Suffrage Association (NAWSA) on February 14, 1920 at their convention in Chicago. It was this group of suffragists that fought for nearly a century to gain the right to vote for women which culminated in the ratification of the 19<sup>th</sup> Amendment. The League's centennial also occurs in 2020.

On behalf of the League of Women Voters of Anchorage, Alaska, in conjunction with the National League of Women Voters (LWVUS), I request that you share my letter with the Citizens' Stamp Advisory Committee. I strongly support the issuance of a commemorative stamp in 2020 honoring the centennial of 19<sup>th</sup> Amendment's ratification.

**Turning Point Suffragist Memorial**

The LWVUS has endorsed the Turning Point Suffragist Memorial Association and its mission to write Carrie Chapman Catt and the other suffragists back into history through the national Turning Point Suffragist Memorial. League founder, Catt, was a visionary who persisted in her endeavor to win suffrage for all American women and when success was imminent she created the League of Women Voters. The League is her lasting legacy. But most do not know who she is or what she and the over five million suffragists accomplished over seven decades — engineering the greatest expansion of democracy the world has even seen on a single day upon ratification of the 19<sup>th</sup> Amendment! Historians like to say that the suffrage movement is the best kept secret in American history—it is.

The memorial is to be dedicated on August 26, 2020, the centennial anniversary of the ratification of the 19<sup>th</sup> Amendment. The event will take place in Occoquan Regional Park in Virginia, part of the historic prison grounds where scores of suffragists were jailed, kept in inhumane conditions and tortured for picketing the Wilson White House. What will be dedicated will depend on funding received. The estimated cost is \$2 million. Collected so far, just under \$1 million with potential large gifts on the horizon. But there is a long way to go. League members are a significant part of the “base” of donors—who are *directly* connected to the suffrage movement.
