#### LWV of ANCHORAGE GENERAL GUIDELINES

<u>Purpose</u>: General meetings, possibly conducted in collaboration with other groups, would serve to educate the membership and general public on these identified specific areas of concern.

<u>Format & Outcomes</u>: A committee of League members would be responsible for soliciting relevant speakers, establishing General meeting outcomes, and upon conclusion of the General meeting, summarizing and making recommendations to the membership on how the information gained from the General meeting may be used to update or validate existing positions.

<u>Additions to Program</u>: Our Bylaws permit additions to our adopted program should we find it necessary and spell out the procedures for doing so at a General meeting.

## Proposed Changes to League of Women Voters of Anchorage Position PLANNING AND ZONING

Proposed additions are underlined; proposed deletions are struck through.

#### Statement of Position:

The League of Women Voters of Anchorage supports comprehensive planning and effective implementation of a plan aimed at quality growth and development and compatible with the following position statements:

#### **Advance Planning:**

Support coordinated advanced planning for transportation systems, schools, and other community facilities within the Municipality.

Recognition of the need for mass transportation facilities.

<u>Support and encourage provision for a system of interconnected greenways, trails, pedestrian amenities and bike lanes for recreation, conservation, alternative transportation, healthy lifestyles, a vibrant economy and a high quality of life.</u>

#### Planning Implementation and Administration:

Support a Municipal zoning ordinance including a zoning map based on comprehensive planning.

Support a Municipal building code.

Support legislative and administrative measures that would prevent frequent reconsideration of zoning in one area.

Support an official map as a means of reserving rights-of-way for future public use.

Support advanced planning and citizen involvement in the decision-making process with regard to school site acquisition.

#### **Residential Development:**

Encourage provision of adequate parks, playgrounds and open spaces, distributed so that people living in all areas of the Municipality will have easy access to such facilities.

Support required dedication as a method of providing parks and open spaces for the Anchorage community.

Support requirements in subdivision regulations for preservation of natural features such as waterfronts, hillsides, trees, and other scenic features.

Outside Sewer Improvement Districts, encourage sufficient separation of residences to prevent well contamination and other hazards.

Support requirements for different levels of improvements based on subdivision density.

Support some minimum level of improvements for all subdivisions.

Encourage acreage or large lot zoning to provide some areas for rural living in the Municipality.

Support limited access to subdivisions from adjoining arterial streets.

Support and encourage provision for sidewalks, walkways, and other facilities for pedestrian traffic.

Support and encourage provision for lanes for bicycles, horses, and snowmobiles in some areas of the municipality.

Support provisions in subdivision regulations calling for flood plain controls.

Support provisions in subdivision regulations calling for planned unit developments (PUDs).

## **Community Appearance:**

Support measures that reduce or eliminate exposed wires and utility poles.

Encourage and support preservation and planting of trees on private properties in the Municipality.

Support adoption and enforcement of an ordinance establishing basic regulation of signs in the municipality.

Downtown and other commercial developments where shoppers walk from store to store, encourage adequate circulation patterns and pedestrian facilities through the use of malls, covered arcades, small parks and other means.

# Proposed Changes to League of Women Voters of Anchorage Position MUNICIPAL BOARDS AND COMMISSIONS

Proposed deletion is struck through; there are no proposed additions

#### **Statement of Position**

The League of Women Voters of Anchorage supports broad participation by all segments of the community on Municipal boards and commissions, effective interaction between related boards and commissions, and the periodic review of the effectiveness of all boards and commissions.

#### **Amplification**

In order to achieve the above, League supports Municipal action and changes that would:

- 1. Increase public awareness of vacancies on boards and commissions.
- 2. Maintain procedural guidelines for citizen application to a board or commission.
- 3. Limit the number of consecutive terms of service on boards and commissions.
- 4. Fill vacancies on boards and commissions within a specified period of time.
- 5. Review and re define all boards and commissions having overlapping jurisdiction with the possible goal of combining them to better serve the public.
- 6. A sunset ordinance should be retained and evaluative criteria should be drawn up prior to considering the elimination of a board or commission.
- 7. Assure that board and commission meeting minutes are maintained in a public place.
