Voting Rights has now become our story too.

From the President:

We frequently have important voting and election issues appearing in the editorials and commentaries in our news. A recent commentary by Frank Baker in the Anchorage Daily News entitled, "We know how to save our democracy. But will we do it?", stirred my thinking about the policy positions established by the League of Women Voters of the United States, and how we use them to inform our actions on the local level.

The LWVUS has a user-friendly document you may not be aware of outlining those policies. It is called "Impact on Issues" and is designed to help League members use LWVUS public policy positions effectively at the national, state, local, and regional levels. Brief summary statements are followed by more detailed information. It occurred to me that many of you may not be aware of this document and would be interested in the information. Here are just a sampling of the positions that seem quite relevant to current events.

Representative Government

Promote an open governmental system that is representative, accountable and responsive.

VOTING RIGHTS

<u>Citizen's Right to Vote</u>: Protect the right of all citizens to vote; encourage all citizens to vote.

ELECTION PROCESS

<u>Apportionment</u>: Support apportionment of congressional districts and elected legislative bodies at all levels of government based substantially on population.

Redistricting: Support redistricting processes and enforceable standards that promote fair and effective representation at all levels of government with maximum opportunity for public participation.

The League of Women Voters is a nonpartisan political organization that encourages informed and active participation in government and influences public policy through education and advocacy. Any person 16 years of age and older, male or female, may become a League member.

Money in Politics (formerly campaign finance): Support campaign finance/MIP regulations that enhances political equality for all citizens, ensures transparency, protects representative democracy from distortion by undisclosed contributions and big money, and combats corruption and undue influenced in government. Support campaign spending that is restricted but not banned. Supports public financing, full disclosure, abolishing SuperPACs, and creating an effective enforcement agency.

<u>Selection of the President</u>: Promote the election of the President and Vice-President by direct-popular-vote. Support uniform national voting qualifications and procedures for presidential elections. Support efforts to provide voters with sufficient information about candidates.

<u>Voter Representation/Electoral Systems</u>: Support electoral systems at each level of government that encourage participation, are verifiable and auditable, and enhance representation for all voters.

CITIZENS RIGHTS

<u>Citizen's Right to Know/Public Participation</u>: Protect the citizen's right to know and facilitate informed understanding and public participation in government decision-making.

EVALUATING CONSTITUTIONAL AMENDMENT PROPOSALS AND CONSTITUTIONAL CONVENTIONS

Amendment Proposals: Consider whether a proposal addresses matters of abiding importance, makes our political system more democratic, protects individual rights, could be achieved by a constitutional amendment or legislative proposal, and is consistent with other League positions.

<u>Constitutional Conventions</u>: Hold Constitutional Conventions only when certain conditions are in place, such as: limited to a specific topic, full transparency, delegates selected by population, and voting by delegates not by states.

Individual Liberties: Oppose major threats to basic constitutional rights.

<u>Public Policy on Reproductive Choice</u>: Protect the constitutional right of privacy of the individual to make reproductive choices.

CONGRESS AND THE PRESIDENCY

<u>Congress</u>: Support responsive legislative processes characterized by accountability, representativeness, decision making capability, effective performance, & transparency.

<u>The Presidency</u>: Promote a dynamic balance of power between the executive and legislative branches within the framework set by the Constitution.

<u>Privatization</u>: Ensure transparency, accountability, positive community impact and preservation of the common good when considering the transfer of governmental services, assets and/or functions to the private sector.

These policies are sound and well-studied. They guide the work of Leagues across the country and serve to inform the work we do on the local level. Over the next few months, the Anchorage LWV will be working to educate the public on our positions and hope you will join us in sharing the information.

March is "Women's History Month"

In 1988, the Alaska Legislature established <u>February 16</u> as <u>Elizabeth Peratrovich Day</u> "for her unceasing efforts to eliminate discrimination and bring about equal rights in Alaska." She was a civil rights activist, Grand President of the Alaska Native Sisterhood, and member of the Tlingit Nation who worked for equality on behalf of Alaska Natives. In the 1940s, her advocacy was credited as being instrumental in passing Alaska's Anti Discrimination Act of 1945, the first

such law enacted in the U.S. In 2020, the U.S. Mint released a \$1 Peratrovich gold coin. The Peratrovich family papers are at the Smithsonian National Museum of the American Indian.

TRACK YOUR BALLOT



SIGN UP at anchoragevotes.com


- ⇒ Provide name, birth year and residence zip code
- ⇒ Choose text, email or voicemail alerts or all three
- ⇒ Set the time period during which alerts can be sent to you

RECEIVE ALERTS

- ⇒ When your ballot package is mailed
- ⇒ When your ballot return envelope is mailed back (if you use USPS)
- ⇒ When MOA Elections receives your ballot return envelope –through the mail, from a ballot drop box or vote center
- ⇒ If your ballot return envelope is accepted for counting <u>OR</u> if there is an issue to be resolved

HAVE CONFIDENCE your vote has been received and counted

- ⇒ Know where your ballot is at all times
- ⇒ Be alerted if there is an issue with your ballot, for quick resolution

LOCAL LEAGUE DELEGATES

- Each local League is entitled to two voting delegates or alternates.
- ◆ Local Leagues with more than 50 members shall be entitled to **one additional** delegate for **each additional** 50 voting members or major fraction thereof.

1 to 50 members = two delegates

76 to 100 members = three delegates (one additional) 126 to 150 members = four delegates (two additional)

You will receive the <u>Second Call</u> with the specifics of the items to be determined by the voting delegates by March 23. In the meantime, local Leagues will be working on program planning and suggestions for action that should be forwarded to the State Board by **Friday**, **March 18**.

All other necessary info including the nominating committee reports should also be submitted to the LWVAK Board of Directors by this date.
