Ballot packages will be mailed March 12, 2024, to qualified voters in the Municipality of Anchorage (Municipality) at their address of record with the State of Alaska Division of Elections. Ballot packages will not be forwarded by the U.S. Postal Service.



### For the Tuesday, April 2, 2024, Regular Municipal Election, qualified voters within the Municipality will:

- Elect the mayor
- Elect one assembly member and three school board members
- Vote areawide on eight bond propositions and one charter amendment
- Voters residing in some service areas will elect members to their service area boards



## **Voting by Mail is as easy as 1-2-3! Safe • Secure • Confidential**

Voters should follow the instructions included in the ballot package and follow these three steps:

- 1. Vote your ballot, filling in the ovals completely in blue or black ink. Place your voted ballot in the enclosed secrecy sleeve and place the secrecy sleeve in your ballot return envelope. (Only one ballot per return envelope.)
- 2. Sign the voter declaration on the back of your ballot return envelope.
- 3. Return your ballot envelope in one of three ways: 1) Place your ballot in a Secure Drop Box (muni.org/elections/dropbox), 2) bring it to an Anchorage Vote Center (muni.org/elections/AVC), or 3) send the ballot through the mail with the U.S. Postal Service using \$0.68 first class postage or one forever stamp. Ballots MUST be postmarked on or before Election Day. If mailing your ballot the day before or on Election Day, ask a postal official to hand-cancel (hand-stamp) the envelope with a postmark.

This **Ballot Review** presents information about eight bond propositions and one charter amendment as well as contact and background information for the mayoral, assembly and school board candidates.

The **Notice of Election** was published in the **Anchorage Daily News** on **Sunday, February 11, 2024**, and will be published again on **Sunday, March 31, 2024**. It is online at **muni.org/elections**. The Notice lists the mayoral, assembly, school board and service area candidates, Anchorage Vote Centers, Secure Drop Box hours and locations, the text of the ballot propositions and charter amendment as well as the Notice of Bonded Indebtedness.

#### **Who May Vote**

Anyone who is a qualified voter of the State of Alaska, a resident of the Municipality 30 days immediately preceding the election, and registered to vote in state elections at a residence address within the Municipality at least 30 days before the election may vote in this election.

# Voting Options Prior to Election Day and on Election Day

You may request a ballot be mailed to a temporary address, vote by fax, or vote by email. You may vote by mailing your ballot, placing it in a secure drop-box, or vote in-person at an Anchorage Vote Center. Ballots MUST be postmarked on or before Election Day. If mailing your ballot the day before or on Election Day, ask a postal official to hand-cancel (hand-stamp) the envelope with a postmark.

Applications to Vote at a Temporary Address must be received by the Clerk's Office by 5 p.m., Tuesday, March 26, 2024. Applications are available at muni.org/elections/tempaddress or by calling 907-243-VOTE (8683).

To vote by fax or email, you must contact the Clerk's Office by calling 907-243-VOTE (8683). Applications to vote by fax or email received after 5 p.m., Tuesday, March 26, 2024, will be processed subject to availability of staff and resources until 5 p.m., Monday, April 1, 2024.

## Voting on Service Area Bonds

Bond-related projects such as roads and parks are sometimes organized into service areas with specific geographic boundaries; only taxpayers in those service areas pay for the bonded projects. Even so, state law requires a pledge of the "full faith and credit" of the whole Municipality, which means that a bonded proposition in a service area must be approved by a majority of voters throughout the Municipality as well as by a majority of voters in the service area.

All areawide bonds are paid for by property owners throughout the Municipality. This applies to Propositions 1 (School Bonds), 6 (Public Safety and Transit), 7 (Areawide Cemetery) and 8 (Areawide Public Restrooms).

Other bond-related projects including Propositions 3 (Anchorage Road and Storm Drainage Service Area), 4 (Parks and Recreation), 5 (Anchorage Metropolitan Police Service Area) and 9 (Chugach State Park Access Service Area) are paid for by property taxpayers in their respective areas.

Qualified voters residing in the Municipality may vote for a candidate listed by filling in the oval completely in blue or black ink next to the name, or writing in the name of a person qualified to hold that office and filling in the oval next to the write-in name. Candidates' names appear in random order on

#### **Voting for Candidates**

- The mayoral race requires a 45% + 1 vote to win outright. If no candidate wins outright, the top two candidates go to a run-off election.
- Assembly members are elected to designated seats. Assembly member candidates win with a simple majority.
- School board members are elected at large, i.e., members represent all areas of the Municipality but are elected to a designated seat. School board candidates win with a simple majority.
- Service area board members are elected by the voters residing in the respective service area. Service area candidates must file a declaration of candidacy, even as a write-in, at least seven days before the election.

NOTE: Anchorage municipal elections are NOT governed by ranked choice voting. In Alaska's 2020 General Election, voters approved an initiative to establish a ranked choice voting system for the state general election. That initiative does not apply to municipal elections.

## Proposition 1 - \$62,370,000 Anchorage School District Capital Improvement Bonds

These bonds would pay for capital improvements for Anchorage School District (ASD) schools as outlined below.

For each \$100,000 of assessed taxable property value (based on the estimated 2024 assessed valuation in the Municipality), the estimated annual increase in taxes is approximately \$12.69 to retire the proposed bonds. There are no new operation and maintenance (O&M) costs.

Property owners throughout the Municipality of Anchorage would be taxed for these bonds.

## Proposition 2 - Charter Amendment Requiring Assembly Confirmation of the Chief Medical Officer

This proposition would amend Anchorage Municipal Charter Section 5.02 – Powers of the mayor as follows (<u>underlined and bolded words</u> are proposed new words):

#### Section 5.02. – Powers of the mayor.

(a) The mayor shall appoint all heads of municipal departments and the chief medical officer of the municipality, subject to confirmation by the assembly, on the basis of professional qualifications. Persons appointed by the mayor serve at the pleasure of the mayor.

## Proposition 4 - \$4,350,000 Anchorage Parks and Recreation Service Area Capital Improvement Bonds

These bonds would pay the costs of renovating and rehabilitating trails and parks and making improvements at various parks and recreational facilities in the Anchorage Parks and Recreation Service Area (APRSA).

For each \$100,000 of assessed property value in the APRSA (based on the estimated 2024 assessed valuation in the APRSA), the estimated annual increase in taxes is \$1.04 to retire the proposed bonds and an annual increase in the municipal tax cap of approximately \$0.75 to pay for annual operation and maintenance (O&M) costs, not to exceed \$241,000.

Only property owners in the APRSA would be taxed for these bonds. The APRSA includes most of the Anchorage Bowl and most of the Hillside. There would be no cost to property owners in Eagle River, Chugiak, Birchwood, Peters Creek, Eklutna, Girdwood, Indian, Bird Creek, and portions of Glen Alps, Rabbit Creek, and Bear Valley. However, because state law requires the full faith and credit of the whole Municipality to be pledged for these bonds, passage requires approval by voters residing in the entire Municipality as well as by voters in the APRSA.

## Proposition 3 - \$47,110,000 Anchorage Roads and Drainage Service Area Roads and Storm Drainage Bonds

These bonds would pay for roads and storm drainage capital acquisition, construction, renovation upgrades and related capital improvements in the Anchorage Roads and Drainage Service Area (ARDSA).

For each \$100,000 of assessed property value in the ARDSA (based on the estimated 2024 assessed valuation in the ARDSA) the estimated annual increase in taxes is \$12.43 to retire the proposed bonds and an annual increase in the municipal tax cap of \$0.17 to pay for annual operation and maintenance (O&M) costs, not to exceed \$48,000.

Only property owners in the ARDSA would be taxed for these bonds. There is no cost to properties in Chugiak, Eagle River, Girdwood, and other areas outside the Service Area. However, because state law requires the full faith and credit of the whole Municipality to be pledged for these bonds, passage requires approval by voters residing in the entire Municipality as well as by voters in the ARDSA.

## **Proposition 5 - \$1,500,000 Anchorage Metropolitan Police Service Area Capital Improvement Bonds**

These bonds would pay for capital improvements to reconstruct the roof and renovate the heating delivery system at Anchorage Police Department (APD) Elmore Station.

For each \$100,000 of assessed property value (based on the estimated 2024 assessed valuation in the Anchorage Metropolitan Police Service Area (AMPSA) the estimated annual costs are \$0.31 to retire the proposed bonds. There are no new operation and maintenance (O&M) costs.

Only property owners in the AMPSA would be taxed for these bonds. The AMPSA consists of areas north of McHugh Creek (other than Fire Island). There would be no cost to properties in Girdwood, Bird, Indian, Rainbow, Portage and other areas outside the AMPSA. However, because state law requires the full faith and credit of the whole Municipality to be pledged for these bonds, passage requires approval by voters residing in the entire Municipality as well as by voters in the AMPSA.

## **Proposition 7 - \$4,100,000 Areawide Cemetery Capital Improvement Bonds**

These bonds would pay for areawide cemetery equipment and capital improvements within the Municipality. Projects expected to be funded include, but are not limited to: Anchorage Memorial Park, Girdwood Cemetery, and Eagle River Cemetery.

For each \$100,000 of assessed property value (based on the estimated 2024 assessed valuation in Anchorage) the estimated annual costs are \$0.83 to retire the proposed bonds and an increase in the municipal tax cap of approximately \$0.01 to pay for annual operation and maintenance (O&M) costs, not to exceed \$5,000.

Property owners throughout the Municipality of Anchorage would be taxed for these bonds.

## **Proposition 6 - \$4,560,000 Areawide Public Safety** and Transit Capital Improvement Bonds

These bonds would pay for capital improvements to acquire new replacement ambulances, acquire and replace transit vehicles and support equipment, undertake signal system, signage, traffic calming and safety improvements, and undertake school zone safety improvements, bus stop improvements, and improvements to transit facilities and centers.

For each \$100,000 of assessed property value (based on the estimated 2024 assessed valuation in the Municipality) the estimated annual costs are \$0.93 to retire the proposed bonds and an annual increase in the municipal tax cap of \$0.33 to pay for annual operation and maintenance (O&M) costs, not to exceed \$125,000.

Property owners throughout the Municipality of Anchorage would be taxed for these bonds.

Proposition 8 - \$5,000,000 Areawide **Public Restroom Bonds** 

These bonds would pay for the installation of standalone, durable-construction public restroom units throughout the Municipality.

For each \$100,000 of assessed property value (based on the estimated 2024 assessed valuation in the Municipality) the estimated annual costs are \$1.01 to retire the proposed bonds and an annual increase in the municipal tax cap of \$0.79 to pay for annual operation and maintenance (O&M) costs, not to exceed \$300,000.

Property owners throughout the Municipality of Anchorage would be taxed for these bonds.

## Proposition 9 - \$4,000,000 Chugach State Park Access Service Area Capital Improvements Bonds

In 2023, Anchorage voters approved creation of the Chugach State Park Access Service Area (CASA), allowing the Municipality to submit bond proposals to the voters. This proposition provides public access improvements to include Canyon Road and parking to the Sunnyside Trailhead.

For each \$100,000 of assessed property value in CASA, (based on the estimated 2024 assessed valuation in the CASA) the estimated annual increase in taxes is \$0.95 to retire the proposed bonds. There are no additional operation and maintenance (O&M) costs.

Only property owners in the CASA would be taxed for these bonds. CASA includes all areas of the Municipality north of McHugh Creek. It does not include Fire Island, areas currently contained within Eagle River-Chugiak Parks and Recreation and Girdwood Valley Service Area, and those areas of the Municipality within Tax District 15 (which contains Rainbow, Indian, Bird Creek and Portage).

However, because state law requires the full faith and credit of the whole Municipality to be pledged for these bonds, passage requires approval by voters residing in the entire Municipality as well as by voters in the CASA.
