Ballot packages will be mailed March 17, 2026 to qualified voters in the Municipality of Anchorage (Municipality) at their address of record with the State of Alaska Division of Elections. Ballot packages will not be forwarded by the U.S. Postal Service.



For the Tuesday, April 7, 2026 Regular Municipal Election, qualified voters within the Municipality of Anchorage will:

- Elect six assembly members and two school board members
- Vote areawide on eight bond propositions, one charter amendment, and one special levy proposition
- Qualified voters residing in certain Limited Road Service Areas will elect members to their respective service area board
- Qualified voters residing in certain service areas will vote on two propositions applicable to their service area



Voting by Mail is as easy as 1-2-3! Safe • Secure • Confidential

Voters should follow the instructions included in the ballot package and follow these three steps:

1. **Vote your ballot, filling in the ovals completely** in blue or black ink. Place your voted ballot in the enclosed secrecy sleeve and place the secrecy sleeve in your ballot return envelope. (Only one ballot per return envelope.)
2. **Read and sign the voter declaration** on the back of your ballot return envelope.
3. **Return your ballot envelope in one of three ways:** 1) Place your ballot in a Secure Drop Box (muni.org/elections/dropbox), 2) send the ballot through the mail with the U.S. Postal Service using first class postage, or 3) bring it to an Anchorage Vote Center (muni.org/elections/AVC). Ballots MUST be postmarked on or before Election Day.

If mailing your ballot the day before or on Election Day, ask a postal official to manually postmark the ballot envelope.

This **Ballot Review** presents information about eight bond propositions, one charter amendment, one special levy, two service area propositions as well as contact and background information for the assembly and school board candidates.

The **Notice of Election** was published in the *Anchorage Daily News* on **Sunday, February 15, 2026** and will be published again on **Sunday, April 5, 2026**. It is online at muni.org/elections. The Notice lists the assembly, school board and service area candidates, Anchorage Vote Centers' hours and locations, Secure Drop Box hours and locations, and the text of the ballot propositions as well as the Notice of Bonded Indebtedness.

Who May Vote?

Anyone who is a qualified voter of the State of Alaska, a resident of the Municipality 30 days immediately preceding the election, and registered to vote in state elections at a residence address within the Municipality at least 30 days before the election may vote in this election. The last day to register to vote for the April 7, 2026 election is March 8, 2026.

Voting Options Prior to Election Day and on Election Day

You may request a ballot be mailed to a temporary address, vote by fax, vote by email, or vote by Secure Document Portal. You may vote by placing your ballot in a secure drop box, mailing your ballot, using the Secure Document Portal, or vote in-person at an Anchorage Vote Center. Ballots MUST be postmarked on or before Election Day. **If mailing your ballot the day before or on Election Day, ask a postal official to manually postmark the ballot envelope.**

Applications to Vote at a Temporary Address must be received by the Clerk's Office by 5 p.m. on Tuesday, March 31, 2026. Applications are available at muni.org/elections/tempaddress or by calling 907-243-VOTE (8683) or by emailing elections@anchorageak.gov.

To vote by Secure Document Portal, email or fax, you must contact the Clerk's office by calling 907-243-VOTE (8683) or by emailing elections@anchorageak.gov. Applications to vote by Secure Document Portal, email or fax received after 5 p.m., Tuesday, March 24, 2026 will be processed subject to availability of staff and resources until 5 p.m. Monday, April 6, 2026.

Bond-related projects such as roads and parks are sometimes organized into service areas with specific geographic boundaries; only taxpayers in those service areas pay for the bonded projects. Even so, state law requires a pledge of the “full faith and credit” of the whole Municipality, which means that a bonded proposition in a service area must be approved by a majority of voters throughout the Municipality as well as by a majority of voters in the service area.

Voting on Service Area Bonds

All areawide bonds are paid for by property taxpayers throughout the Municipality. This applies to Propositions 1 (Anchorage School District Bonds), 5 (Community Facilities Bonds), 6 (Public Safety Bonds), and 9 (Anchorage School District Special Levy).

Other bond-related projects, including Propositions 2 (Anchorage Roads and Storm Drainage Service Area), 3 (Anchorage Parks and Recreation Service Area), 4 (Anchorage Metropolitan Police Service Area), 7 (Anchorage Fire Service Area), and 8 (Chugach State Park Access) are paid for by property tax payers in their respective service area.

Qualified voters residing in the Municipality may vote for a candidate listed by **filling in the oval completely** in blue or black ink next to the name, or writing in the name of a person qualified to hold that office and filling in the oval next to the write-in name. Candidates’ names appear in random order on the ballot.

Voting for Candidates

- Assembly members are elected to designated seats. Assembly member candidates receiving the most votes win.
- School board members are elected at large, i.e., members represent all areas of the Municipality but are elected to a designated seat. School board candidates receiving the most votes win.
- Service area board members are elected by the voters residing in their respective service area. Service area candidates must file a declaration of candidacy, even as a write-in, at least seven days before the election.

NOTE: Anchorage municipal elections are NOT governed by ranked choice voting. In Alaska’s 2020 General Election, voters approved an initiative to establish a ranked choice voting system for the state general election. That initiative does not apply to municipal elections.

Proposition 1 — \$79,460,000 Anchorage School District Capital Improvement Bonds

These bonds will be used to pay costs of constructing, upgrading, planning, designing and renovating school facilities and educational facility building life extension projects within the Anchorage School District (ASD).

For each \$100,000 of assessed taxable property value (based on the estimated 2026 assessed valuation in the Municipality), the estimated annual increase in taxes is \$7.82 to retire the proposed bonds if the State of Alaska chooses to make full reimbursement on the \$79,460,000. Without State reimbursement, the estimated annual increase in taxes is \$15.43. There are no new operation and maintenance (O&M) costs.

Property owners throughout the Municipality of Anchorage will be taxed for these bonds.

BALLOT STATUS

Voters can find out the status of their ballot by using BallotTrax at anchoragevotes.com, where voters can sign up for texts, email, or voicemail alerts regarding ballot status.

Voters will be required to provide information over the telephone to confirm identity.

Proposition 2 – \$38,450,000 Anchorage Roads and Drainage Service Area Capital Improvement Bonds

These bonds will be used to acquire, construct, renovate, upgrade and undertake certain road improvements, roadway safety improvements and storm drainage and treatment improvements in the Anchorage Road and Drainage Service Area (ARDSA).

For each \$100,000 of assessed property value in the ARDSA (based on the estimated 2026 assessed valuation in the Service Area) the estimated annual increase in taxes is \$8.62 to retire the proposed bonds and an annual increase in the municipal tax cap of \$0.14, not to exceed \$45,000, to pay for operation and maintenance (O&M) costs.

Only property owners in the ARDSA will be taxed for these bonds. There will be no cost to properties in Chugiak, Eagle River, Girdwood and other areas outside the ARDSA. However, because state law requires the full faith and credit of the whole Municipality to be pledged for these bonds, passage requires approval by voters residing in the entire Municipality as well as by voters in the ARDSA.

Proposition 3 - \$6,050,000 Anchorage Parks and Recreation Service Area Capital Improvement Bonds

These bonds will be used to pay for the costs of renovation and rehabilitation of park, trail, and recreational facilities in the Anchorage Parks and Recreation Service Area (APRSA).

For each \$100,000 of assessed property value in the APRSA (based on the estimated 2026 assessed valuation in the Service Area), the estimated annual increase in taxes is \$1.22 to retire the proposed bonds and an annual increase in the municipal tax cap of \$1.13 to pay for operation and maintenance (O&M) costs, not to exceed \$415,000.

Only property owners in the APRSA will be taxed for these bonds. The APRSA includes most of the Anchorage Bowl and most of the Hillside. There will be no cost to property owners in Chugiak, Eagle River, Girdwood and other taxpayers outside the APRSA. However, because state law requires the full faith and credit of the whole Municipality to be pledged for these bonds, passage requires approval by voters residing in the entire Municipality as well as by voters in the APRSA.

Only property owners in the AMPSA will be taxed for these bonds. The AMPSA consists of areas north of McHugh Creek (other than Fire Island). However, because state law requires the full faith and credit of the whole Municipality to be pledged for these bonds, passage requires approval by voters residing in the entire Municipality as well as by voters in the AMPSA.

Any director may be removed at any time upon a vote of at least eight members of the assembly, or a vote of at least six members of the assembly and concurrence of the mayor given within seven days after the assembly's action.~~

~~[(b) The utility shall be operated and compete in accordance with prevailing industry practices and in a manner which will provide a dividend to the municipality.~~

~~[(c) The board of directors may incur debt for the utility and may exercise the power of eminent domain on its behalf only with prior approval of the assembly. The assembly may annually appropriate to the general fund any amount of utility revenues in excess of that required to discharge the utility's service obligations, meet its approved capital improvement program, and maintain financial integrity.~~

~~[(d) The Anchorage Telephone Utility and its board of directors shall be subject to the authority of the municipal ombudsman as provided by ordinance.~~

~~[(e) The compensation for the Anchorage Telephone Utility board of directors shall be determined by the commission on salaries and emoluments in the same manner as provided for elected officials in section 5.08(c) and section 5.08(d) of this Charter.~~

~~[(f) The Anchorage Telephone Utility shall operate on the same fiscal year as the Municipality of Anchorage, and shall submit its budget to the mayor on the same schedule as that required of other municipal utilities. The assembly shall have final approval of the utility budget.~~

~~[(g) In addition to any amounts the assembly may appropriate pursuant to subsection (c) of this section, the Anchorage Telephone Utility shall pay a municipal utility service assessment if established by the Anchorage Assembly by ordinance.~~

The assembly, by ordinance, shall implement this section to provide for the independent management and operation of the utility consistent with this section. Proposition 11 — Increase the Mill Rate for the Bear Valley Local Road Service Area (LRSA)

The current mill levy for the Bear Valley LRSA is 1.50 mills. This proposition will increase the mill levy 0.75 for a total of 2.25 mills. The increase will be used exclusively for maintenance of roads and snow plowing.

For each \$100,000 of assessed taxable property value (based on the estimated 2026 assessed valuation in the Bear Valley LRSA) the estimated annual increase in taxes for property owners within the Bear Valley LRSA will be approximately \$75.

The maximum mill rate in the Eagle River SLSA is 0.5 mills. Property owners within the Eagle Bluff Estates will incur an increase in property tax to pay for the operation and maintenance of street lights.

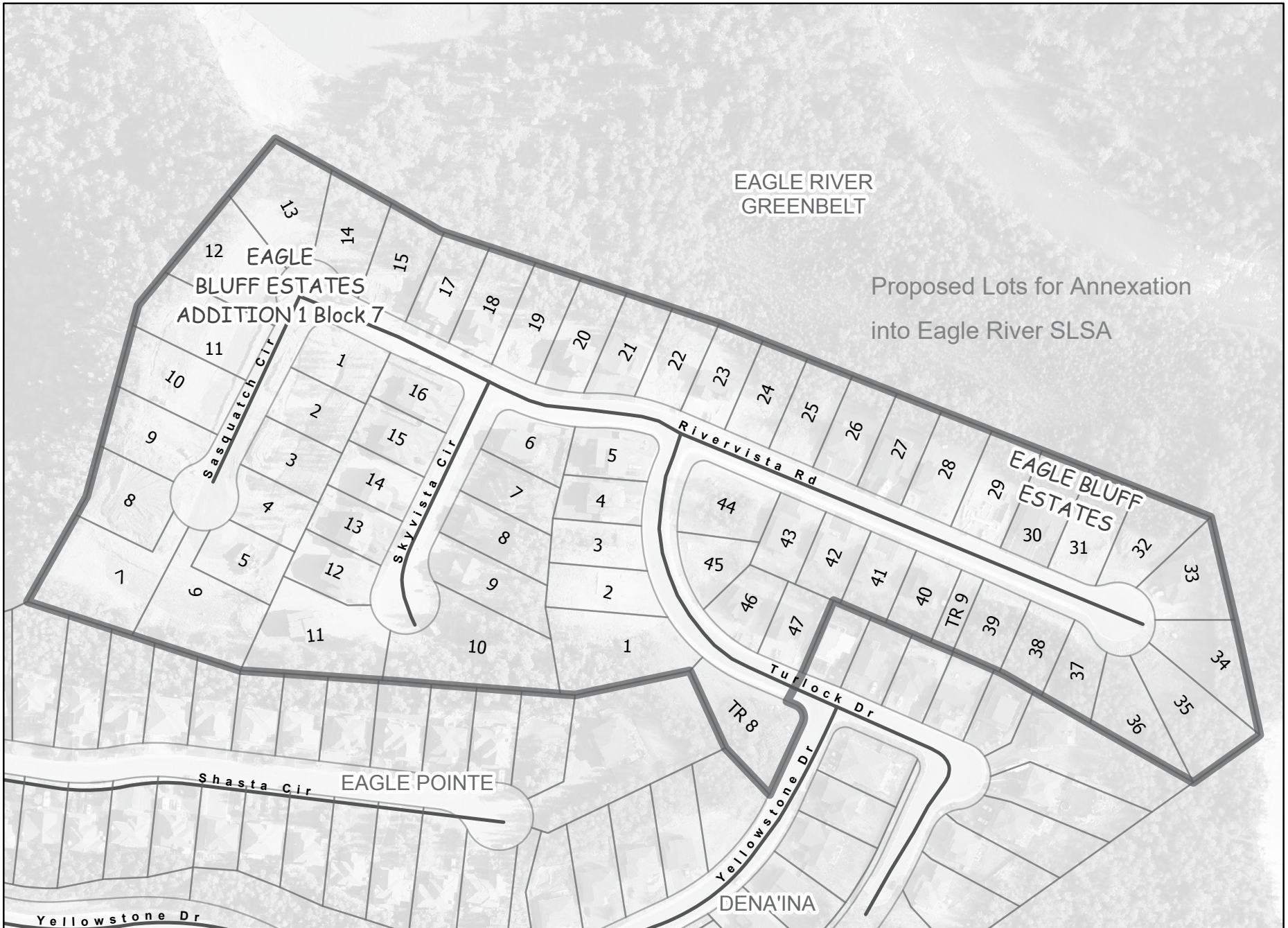


Exhibit A: Eagle River Street Light Service Area - Eagle Bluff Estates Subdivision

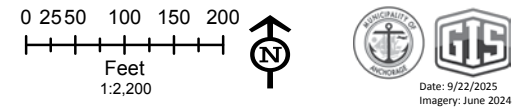
